The current month's tuition is due upon enrollment. Subsequent tuition is due on a monthly basis, **on or before the first class of each month**. We send invoices via email on the 25th of each month. We pro-rate tuition for months with fewer or more than four occurrences of your class day. You are enrolled on an ongoing basis for the school year unless you notify us that you wish to withdraw. **To withdraw your enrollment, please notify us before the end of the month that you do not plan to continue in the following month.**

Tuition includes personalized lesson plans for your child, follow-up calls and study reminders throughout the week after classes. We greatly appreciate any advance communication you can provide about missed classes, so that we can use our staff efficiently and allow other students to take your child's spot for a makeup class. If you have a planned absence and you **notify us before your tuition is due**, we will pro-rate your tuition as a courtesy. **We do not provide refunds for missed classes after tuition is due, nor can we offer "rollover" credits to the following month if you do not attend all the classes for which you have paid.** If your child misses a class due to illness or a scheduling conflict, as a courtesy we will offer a makeup class **for a time slot in which they are not currently enrolled**, if space is available, at our discretion. **Makeups are limited to 3**; once you have accumulated 3, you must use one before you can accumulate another makeup credit. Makeups expire at the end of the current school year.

We accept cash, personal checks, Mastercard or Visa. If you opt for credit card payment, your card will be charged on the first of each month for that month's tuition.
